Safety Instrumented Function Verification: The Three Barriers
Safety Instrumented Systems must be independent from all other control systems that control the same equipment in order to ensure SIS functionality is not compromised. SIS is composed of the same types of control elements (including sensors, logic solvers, actuators and other control equipment) as a Basic Process Control System (BPCS). However, all of the control elements in an SIS are dedicated solely to the proper functioning of the SIS.
